WAIVER OF RIGHTS

I, the undersigned (parent or guardian of a minor rider) execute this waiver of the undersigned's rights to sue and agree to assume all risks inherent in equine activities under Subsection 3.1-796.132 of the Code of Virginia and further agree that I understand the risks inherent in participating in equine activities at Dorey Park, Darbytown Road, Henrico County, Virginia, including (i) the propensity of an equine to behave in dangerous ways which may result in injury to the participant or the equine, (ii) the inability to predict an equine's reaction to sound, movements, objects, persons or animals; and (iii) hazards of surface or subsurface conditions located at the above activity location.

This waiver executed by undersigned shall be effective until expressly revoked in writing. The revocation shall become effective thirty (30) days after it is delivered to Varina Rising Stars 4-H at Dorey Park Shows.
